

Consent to Personal Data Processing

(hereinafter referred to as “**Consent**”) given to **CSGM a.s.**, having its registered office at U Rustonky 714/1, Karlín, 186 00 Prague 8, Company ID No.: 013 84 694, registered with the Municipal Court in Prague, File Ref. No. B 19596, (hereinafter also referred to as “**Controller**”) by a data subject, whose identification data to the following scope: business name or name of the individual - entrepreneur, registered office or place of business, identification number, contact details (e-mail address, phone number) was given by completing the contact details on <https://csg.promitea.com/> (hereinafter referred to as “**Data Subject**”, the Controller and the Data Subject are hereinafter also jointly referred to as “**Parties**” or individually as a “**Party**”).

- 1/ The Controller is a company with its registered office in the Czech Republic, which is a servicing company of a group of business corporations, whose controlling entity within the meaning of Section 79 of the Act No. 90/2012 Coll., the Business Corporations Act, is CZECHOSLOVAK GROUP a.s., Company ID No.: 034 72 302, having its registered office at U Rustonky 714/1, Karlín, 186 00 Prague 8, registered in the Commercial Register administered by the Municipal Court in Prague, File Ref. No.: B 20071 (hereinafter referred to as “**Czechoslovak Group**”), and of CSG DEAL a.s., Company ID No.: 118 58 095, having its registered office at U Rustonky 714/1, Karlín, 186 00 Prague 8, registered in the Commercial Register administered by the Municipal Court in Prague under File Ref. No.: B 26641, which is an operator of the electronic central purchasing portal at <https://csg.promitea.com/>
- 2/ By clicking on the “I agree to the processing of personal data” box and filling in your contact details at <https://csg.promitea.com/>, you give the Controller this Consent to the processing of your personal data manually and automatically by itself and through its subcontractors appointed by the Controller, which you provide to the Controller or which the Controller otherwise obtains, for the purposes and reasons set out below (hereinafter also collectively referred to as “**Purposes**” or individually as a “**Purpose**”):
 - Operation of the electronic central purchasing portal;
 - Communication of interest in accepting an offer via the electronic central purchasing portal;
 - Receipt and evaluation of offers via the electronic central purchasing portal;
 - Communication with trading participants via the electronic central purchasing portal;

- 3/ By clicking on the box “I agree to receiving advertising and information materials” and filling in your contact details at <https://csg.promitea.com/>, you give the Controller your consent to manually and automatically process your personal data that you provide to the Controller or that the Controller otherwise obtains for the Purposes of marketing and sending advertising offers, but only if you indicate that you expressly agree to receiving advertising and information materials, otherwise your personal data is not processed for this Purpose. The reason for processing your personal data for the Purpose of marketing and sending advertising offers is to offer similar products or services that the Controller has already provided or provides to you, to offer complementary products or services to those products or services that the Controller has already provided or provides to you and to deepen the customer relationship between the Controller and you in order to improve the quality of the products or services that the Controller provides or intends to provide to you and its other customers. If you wish to have your data processed for the Purpose of marketing and sending advertising offers, please click on the “I agree to marketing and advertising” link, otherwise your personal data will not be processed for these marketing and advertising Purposes.
- 4/ The Controller hereby informs you, as a Data Subject, that you are entitled to contact the Controller electronically in all matters related to the processing of your personal data via the contact details listed at: <https://czechoslovakgroup.com/cs/kontakt>, by mail marked with the following note: Data Protection, and to exercise your rights against the Controller in the same way, and that, except for the performance of contractual obligations concluded between you and the Controller or obligations arising directly from legal regulations, the legal basis for the processing of your personal data by the Controller is this Consent. The Controller hereby informs you as a Data Subject that you have the following rights in relation to the processing of your personal data in particular: (a) the right to access any of your personal data; (b) the right to rectification of your personal data; (c) the right to erasure of your personal data (“right to be forgotten”); (d) the right to restriction of the processing of your personal data; (e) the right to portability of your personal data; (f) the right to object to the processing of your personal data; (g) the right to withdraw consent to the processing of your personal data at any time. If you believe that your personal data is being processed in violation of legal regulations or is incorrect, you have the right to contact the Controller with a request for rectification and if the request is found to be justified, the Controller will immediately rectify the defective situation. This is without prejudice to your right to lodge a complaint directly with the Office for Personal Data Protection.
- 5/ By giving this Consent, you agree to the Controller processing automatically and manually your personal data provided to the Controller or obtained by the Controller

for the Purposes in its databases and elsewhere, to the following extent (hereinafter collectively referred to as “**Personal Data**”):

- a. name and surname, degree;
- b. email address, phone number(s);
- c. cookies and the IP address of the computer from which you are accessing the Controller.

6/ This Consent is given for the duration of your contractual relationship with the Controller or any Czechoslovak Group entity and for a period of ten years from the termination of such contractual relationship and, in the absence of a direct contractual relationship between you and the Controller, for a period of ten years from the date of its giving to the Controller. 7/ You agree that as the Controller is part of the Czechoslovak Group, which operates a common administrative and operational system, the Controller is entitled, on the basis of this Consent and for the Purposes, to share your Personal Data within the Czechoslovak Group for the more effective fulfilment of the Purposes and the protection of the Controller’s legitimate interests and you agree to the entry of your Personal Data in this system throughout the term of this Consent.
